Contest Rules

Description

The City of Frisco Parks and Recreation wants to showcase the photographic talent of our residents on the cover of Play Frisco Magazine. Submit your best photos of what “play” looks like for you in Frisco. The following categories are drawn from subjects of special interest to the City of Frisco Parks and Recreation.

1. Nature: Animals, plants and landscapes in Frisco.
2. People at play: Portraits and photos of groups or individuals playing at a [Frisco public park](#) or other [City-managed facility](#) (Frisco Athletic Center, Frisco Heritage Museum, etc.).

Eligibility

Applicants must reside in Frisco, Texas or attend a Frisco ISD school and must comply with these Official Rules.

Contest Rules

Photo contest begins August 1, 2022. Photos must be uploaded on or before October 1, 2022, by 11:59 p.m. Late entries will not be accepted.

Each person may submit up to 5 photos for consideration.

Photos may not be a copy or duplicate of any previously published photographs. All photographs must be original and must not infringe on the copyrighted content or other rights of any other party. By submitting a contest application, the applicant represents and warrants that the applicant has the legal right to use each photograph submitted and to submit each photograph for use by the City of Frisco.

All submitted photos will be owned by the City of Frisco. The City of Frisco:

- May use the photos in promotional materials, public information materials, reproductions, etc., without compensation to applicants.
- May reproduce the winning designs without compensation to applicants.
- Has the right to use the winners’ names for promotional purposes without compensation to applicants.

By signing the Waiver, applicants agree to abide by the rules and regulations stated here and acknowledge that in the event of a disagreement, the judge’s decisions are final.

Photos must be uploaded on or before 11:59 p.m. on October 1, 2022.

Photos must not include company logos or product brands.

Photos must not be framed or mounted.

Photos must be submitted in .jpeg or .jpg and no larger than 10 MB. Digital photographs should be taken at the highest resolution possible.

Judging

Artwork selection criteria includes:

- Does the artwork comply with the Eligibility and Submission requirements listed above? Failure to follow any of those requirements will result in immediate disqualification from consideration.
- Does the artwork reflect the shared values of the City of Frisco?
- Uniqueness and originality
- Visual impact

Entries will be judged by members of the Play Frisco Business Services division.

All judgments are final.

The Play Frisco Magazine Photo Contest is not intended to constitute or establish a public forum; rather, it is intended to be an expressive activity of the City of Frisco as a governmental entity. By submitting photographs for consideration as part of the Program, you agree that the Contest and display of selected photos constitute government speech and that the City has final authority over all aspects of the manner and location of display of selected artwork.

Prize

One winner will be selected.

The winning photo will be on the cover of an upcoming edition of Play Frisco Magazine.

The winning photo will be showcased on the Play Frisco website and social media platforms.

The City of Frisco will notify winners via the contact information provided at the time of entry; the City of Frisco may disqualify anyone who fails to respond to the notification within five business days.
