All fences must be on or inside the property line. Maximum height of fence in rear is 8 feet from grade. Maximum height for fences placed in front of building line is 4 feet. Fences on shared property lines shall not disrupt existing drainage. Retaining wall details over 3 feet in height must be signed and sealed by a professional engineer.

The Undersigned applicant certifies that the project described herein will be built in accordance with plans and specifications submitted at time of application. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. Granting of a permit does not presume to give authority to violate or cancel the provisions of any local or state law regulating construction or the performance of construction. When a permit has not been issued within 180 days following the date of application, the application and plan review will expire.
